All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the east side of Langdon Street, near the City of Greenville, being shown as a portion of Lot 87 on a plat of Morgan Hill Addition, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book A, at Page 70, and having, according to survey of J. C. Hill, Surveyor, April 7, 1948, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the northeastern corner of said Lot No. 87, and running thence N. 83-30 W. 93 feet with the Monaghan Mills line to an iron pin on eastern side of Langdon Street, as surveyed by R. E. Dalton, Engr.; thence S. 0-29 E. 84.6 feet along the eastern side of said Langdon Street to an iron pin; thence N. 83-38 E. 78.7 feet to an iron pin on the eastern line of said Lot No. 87; thence N. 13-30 E. 66.1 feet to the beginning corner; being the same conveyed to me by J. W. Lunsford by deed dated June 19, 1953 by deed recorded in the R. M. C. Office for Greenville County in Deed Vol. 480, at Page 290.
