"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of East North Street in the City of Greenville, and shown as a portion of Lot No. 2 of Block 5, shown on plat of Boyce Addition, recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book ZZ, at pages 934 and 935, and having the following metes and bounds, to-wit:

BEGINNING at a point on the Southern edge of East North Street, said point being 100 feet West of the Southwest intersection of Manly Street and East North Street and running thence S. 16-07 E. 170.45 feet to a point on the Northern edge of a 15 foot alley; thence with said alley, S. 76-0 W. 35.66 feet to a point; thence N. 16-07 W. 170.45 feet to a point on the Southern edge of East North Street; thence with said Southern edge of East North Street, N. 76-0 E. 35.66 feet to the beginning point.
