All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Simpsonville, on the Southern side of Seminole Drive, being shown as Lot No. 21 on Plat No. 5 of West Georgia Heights, recorded in Plat Book GSG at Page 120 in the R. M. C. Office for Greenville County, and having according to said plat the following metes and bounds:
