account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly
paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has grant-
ed, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and as-
signs:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and
being in the State of South Carolina, County of Greenville.

William S. T. and Mary Anders all that piece, parcel or lot of land lying in Greenville County
O'Nela Township, State of South Carolina and having the following metes and bounds to wit:

Beginning on an iron pin on the County Road leading from Highway No. 115 to the Pine Log
Ford Road and runs thence 208.71 feet with said road N. 39-30E, to an iron pin thence in a
northwest direction 208.71 feet to an iron pin; thence in a southwest direction 208.71 feet
to an iron pin on the C. S. Tate line; thence with said line 208.71 feet S. 67-35 E. to the
