C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Seven Thousand Eight Hundred and No/100ths**-----

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northern side of Camden Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 249 as shown on a plat of Rockvale, Section Two, prepared by J. Mac Richardson, dated July, 1959, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at page 109, and having according to said plat the following metes and bounds:
