"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon. situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one mile northeast from Chick Springs, being shown as all of Lots Nos. 5 and 6 on plat of property made for Peter H. Wuest by R.K. Campbell, dated January 24, 1961, which plat is recorded in the R.N.C. Office for Greenville County, and having the following courses and distances:

BEGINNING at an iron pin on the northern side of Winesap Way, at the joint front corner of Lots Nos. 4 and 5, and running thence N. 24-35 W. 200 feet to a point on the line of Conway Woods; thence S. 65-25 W. 210 feet along said property to point on theeastern side of Badger Drive; thence S. 24-35 E. 175 feet along said Drive to an iron pin; thence on a curve 25 feet, the chord of which is S. 60-35 E. to an iron pin on the northern side of Winesap Way; thence with Winssap Way, N. 65-25 E. 185 feet to the beginning corner.
