That he is a duly licensed attorney at law and has practiced his profession in Asheville, North Carolina, since admission to the North Carolina Bar in the month of August, 1924.

That from November 11, 1944, to and including March 15, 1963, Affiant was also engaged in the banking business, being a stockholder in and Secretary and Attorney for CAROLINA INDUSTRIAL BANK of Asheville, North Carolina, which on the last mentioned date merged with and was succeeded by FIRST CITIZENS BANK AND TRUST COMPANY. That Affiant is presently a stockholder, Director, and Attorney for said FIRST CITIZENS BANK AND TRUST COMPANY, which maintains a banking office at 20 S. Pack Square, Asheville, North Carolina.

That said CAROLINA INDUSTRIAL BANK on or about April 10, 1952, purchased from LILLIE GLOVER of Asheville, North Carolina, an installment Promissory Note in the amount of Four Thousand Dollars (\$4,000.00) executed by ROSA T. BOYD and husband, WILLIAM B. BOYD. That the Makers secured said Note by Deed of Trust on real property situate at 3 Cross Street, Asheville, North Carolina, and by Mortgage on real property situate at 513 Oscar Street, Greenville, South Carolina. Said Deed of Trust was recorded in the Office of the Register of Deeds for Buncombe County, North Carolina, on April 10, 1952, in Book of Deeds of Trust 496 at Page 647, and said Mortgage was recorded shortly after said date in the Office of the Register of Mesne Conveyances for Greenville, South Carolina, in Book 527 at Page 511.

That the above described installment Promissory Note bears the endorsement of the Payee thereof, to-wit: LILLIE GLOVER, and Affiant was present at the time of said endorsement and saw and observed the Endorser sign and affix her name thereto on the reverse thereof.

That on November 4, 1957, the Makers of said installment Promissory Note, to-wit: ROSA T. BOYD and WILLIAM B. BOYD, completed the full payment of said Note, at which time Affiant, in his capacity as Secretary of said CAROLINA INDUSTRIAL BANK and in behalf of said Institution marked said Note and the Deed of Trust securing same as follows: "Paid in full Nov. 4, 1957 Carolina Industrial Bank (Holder) by Chas. G. Lee Jr., Secretary."
