Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All those lots of land in the county of Greenville, state of South
Carolina, known and designated as Lots Nos. 37 and 38, Block D, on plat
of Buena Vista subdivision, recorded in the RMC Office for Greenville
County in plat book W at page 11 & 29 of the RMC Office for Greenville
County, S. C., said lots having in the aggregate a frontage of 70 feet
on the east side of Rose Garden Street, a parallel depth of 150 feet and
a rear width of 70 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
