WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifteen Thousand, Two Hundred and No/100

DOLLARS (\$15,200.00), with interest thereon from date at the rate of Six & one-half (6½) per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the Western side of Cherokee Drive, and being shown as Lot No. 7 on plat No. 2 of West Georgia Heights, which plat is recorded in Plat Book WW at Page 149, said lot having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Cherokee Drive at the joint front corner of Lots 7 and 8 and running thence with the joint line of said lots N. 89-47 W. 200 feet to an iron pin at the rear of Lot 15; thence with the line of Lot 15 N. 0-35 E. 82.7 feet to an iron pin on the line of property of James W.
