MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, Leroy V. Dyer and Marion L. Dyer, of Greenville County,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and tikely indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Four Thousand, Six Hundred and No/100----- (\$ 4,600,00 Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments of Forty and 08/100----bollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment—of principal with the last payment, if not sooner paid, to be due and payable—15. . years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Martgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings, and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagor for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor'in hand well and truly paid-by the Mortgagee at and before the sealing of these presents, the receipt whereof is needly acknowledged has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 25 as shown on plat of West Boulevard recorded in the R. M. C. Office for Greenville County in Plat Book F at page 246 and being more particularly described according to a more recent survey by J. C. Hill as follows:

"BEGINNING at an iron pin on the south side of Wilbanks Street, which pin is 214. 3 feet from the intersection of Wilbanks Street and Curtis Road, at the joint front corner of Lots 25 and 26 and running thence along the south side of Wilbanks Street, N. 79-45 E. 60 feet to an iron pin, corner of Lot 23; thence with the line of said lots, S. 10-15 E. 158.1 feet to an iron pin; thence S. 78-50 W. 60 feet to an iron pin, rear corner of Lot 26; thence with the line of said lot, N. 10-15 W. 159 feet to the point of beginning; being the same conveyed to us by Bernice Mize by deed dated April 25, 1955 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 524 at page 2."
