All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northwestern side of Delray Circle near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 10 as shown on a Final Plat of Section Two, Farmington Acres, prepared by Carolina Engineering and Survey Service, dated September 24, 1964, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB at page 27, and having according to said plat the following metes and bounds:
