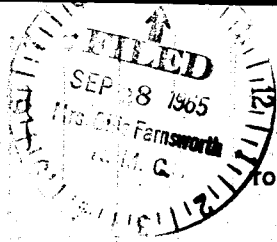

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, We, John Robinson and Vivian Robinson

(hereinafter referred to as Mortgagor) is well and truly indebted unto BARCO, INC.,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of One Thousand Seven Hundred Fifty Seven and 34/100

Dollars (\$ 1757.34) due and payable in equal monthly installments of Forty One and 28/100 (\$41.28) Dollars each, first payment due and payable on the fifteenth day of October, 1965, and a like amount to be paid on the fifteenth day of each and every month thereafter for a total of forty eight (48) months, and until paid in full and as more fully set forth in the Real Estate Note executed this date,

with interest thereon from date at the rate of -six- per centum per annum, to be paid as set forth in said Note

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Township of Chicks Springs, and being on the South side of a paved County road, known and designated as Lincoln Road, about two miles from the city of Taylors, S.C., being also known as lot NUMBER THREE as shown on a survey prepared by G. A. Ellis, dated 12-7-46.

FOR VALUE RECEIVED the undersigned does hereby grant, bargain, sell, and release unto NORTH AMERICAN ACCEPTANCE CORPORATION, 1252 W. Peachtree St., N.W., Atlanta, Georgia, all its right, title and interest to the within mortgage and to the note for which said mortgage is given to secure, this 28- day of August, 1965.
