ALL that certain piece, parcel or lot of land with improvements thereon situate, lying and being on the Southern side of South Estate Drive, near the City of Greenville, County of Greenville, State of South Carolina, being shown and designated as LOT NO. 17 on a plat of Crestwood, Inc. made by J.C. Hill, Surveyor, February 28, 1949, recorded in the RMC Office for Greenville County in Plat Book "S", at page 189.
