NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon,

situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, containing one acre, more or less, on the eastern side of Geer Highway, #276, and bounded by lands now or formerly of W. T. Newby, Nannie K. Hunt, et al, and being more particularly described as follows:

BEGINNING at a stone on Geer Highway, and running thence N. 65-1/2 E. 3.79 chains to iron pin; thence N. 31 W. 280 chains to iron pin; thence S. 65-1/2 W. 3.79 chains to an iron pin on the east side of Geer Highway; thence with said Highway S. 31 E. 2.80 chains to beginning corner, being the same property conveyed to the mortgagor herein by deed of B.
