All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer, at the northwest intersection of Brockman Street and Lancaster Avenue, being shown and designated as a portion of Lots nos. 99 and 100 on a plat of the W. H. Brockman Estate, duly recorded in Plat Book H, page 132 in the R. M. C. Office for Greenville county, and having the following courses and distances: Beginning on an iron pin at the northwest intersection of Lancaster Avenue and Brockman Street, and running thence along the west side of Brockman Street N.12-00 E.59 feet to an iron pin; thence N.78-00 W.140 feet to an iron pin on line of Lot No. 101; thence along the line of Lot No. 101, S.12-00 W.59 feet to an iron pin on the northern edge of Lancaster Avenue; thence along said Avenue, S.78-00 E.140 feet to the point of beginning.
