"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located about two miles South of the City of Green, near Pleasant Grove, being shown and designated as Lot # ll, as shown on a plat prepared for Grantor, by J. Q. Bruce, R. S., dated March 21, 1961, being more particularly described as follows:

BEGINNING at an iron pin on bank of new cut road and hard surface road and running thence S. 69-58 E. 236 feet to an iron pin, corner of Lot # 16; thence S. 20-02 W. 180 feet to an iron pin, rear corner of Lots # 16 and 12; thence N. 69-58 W. 236 feet to an iron pin on bank of new cut street; thence along said street, N. 20-02 E. 180 feet to the point of beginning.
