"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, In Highland Township, 1 ring on the west side of the Jordan Road about one-half mile south from the Old Jordan High School, bounded on the north by lands of G.W. Neely, on the east by said road, on the south by lands of Mary Sue Sherbert, and on the west by lands of John C. Clement and Mary Sue Sherbert, and having the following courses and distances:
