MODIFICATION AGREEMENT

WHEREAS, on the 1st day of September, 19 65, First Federal Savings and Loan Association of Greenville, S. C. made a mortgage loan to C. A. Burns and Hazel F. Burns covering Lot 34 located on Kenilworth Dr. Road, in a subdivision known as Wellington Green, II, in the sum of \$ 20,000.00 on a basis of approximately 25 years with payments thereon at the rate of \$ 128.87 per month, with interest at the rate of 6 % per annum; and

WHEREAS, the principal balance due on said mortgage loan has now been reduced to the sum of \$ 20,000.00; and

WHEREAS, it is now desired by the parties hereto that the terms of the loan be amended so as to cover a payment period of approximately 25 years with payments thereon at the rate of \$ 125.83 per month, with interest at the rate of 5-3/4 % per annum, to be computed and paid monthly. NOW THEREFORE,

KNOW ALL MEN BY THESE PRESENTS that in and for the mutual consideration and premises hereinabove expressed, the First Federal Savings & Loan Association of Greenville does hereby authorize the mortgagor C. A. Burns and Hazel F. Burns to make payments on the aforesaid mortgage being recorded in the R. M. C. office for Greenville County in Mortgage Book 984, at page 179 at the rate of \$ 125.83 per month, bearing interest at the rate of 5-3/4 % per annum, payable monthly, and that so long as said payments are made promptly on the first day of each and every calendar month this loan shall not be considered delinquent, but should the mortgagor fail to make said payments as agreed, then, in that event, the holder of this mortgage may institute foreclosure proceedings without further delay according to the terms as set out in said note and mortgage.

IT IS EXPRESSLY UNDERSTOOD AND AGREED that no other terms of the aforesaid note and mortgage are in any way changed, altered, or amended by this agreement.
