All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville, Bates Township**, situate on the southern side of Highway 276, referred to as the Geer Highway, according to plat of S. T. and M. C. Tate of record in the R.M.C. Office in plat book "I" at Page 155, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Geer Highway at the corner of property of Giles Walter Banks, which was conveyed to him by Raymond C.
