NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs
Township, on the south side of West Poinsett Street and the east side of James Street in the City of Greer, and having courses and distances according to survey and plat by H. . Brockman and John A. Simmons, Registered Surveyors, dated April 22, 1960, as follows:

BEGINNING at an iron pin at the intersection of West Poinsett Street and James Street, at back edge of sidewalk, and running thence along the edge of sidewalk of West Poinsett Street, S. 69-12 E. 80 feet to an iron pin, corner of F. L. Crow property; thence along the line of the Crow property, S. 21-30 W. 199.8 feet to an iron pin; thence N. 68- 41 W. 80 feet to an iron pin on the east side of James Street; thence along said street, N. 21-30 E. 198.9 feet to the beginning corner.
