"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the eastern side of Scarlett Street, in the City of Greenville, being shown and designated as Lot 246 on plat of Sherwood Forest, recorded in Plat Book GG at pages 70-71, and described as follows:**

**BEGINNING at an iron pin on the eastern side of Scarlett Street, joint front corner of Lots 245 and 246, and running thence with Lot 245, S. 76-44 E. 161.5 feet to pin; thence S. 12-50 W. 75 feet to pin at the rear corner of Lot 247; thence with line of Lot 247, N. 76-44 W. 162.1 feet to pin on the Eastern side of Scarlett Street; thence with the eastern side of said Street N. 13-16 E. 75 feet to the beginning corner.**
