MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Edward H. Hembree

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Emma L. Flinkingshelt, as Tr., & Emma L. Flinkingshelt, as Tr. & Executrix under Will of Elizabeth H. Babb, deceased (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of -----

Sixty-Three Hundred Fifty and No/100 ----- DOLLARS (\$6350.00 ),

with interest thereon from date at the rate of ----- per centum per annum, said principal and interest to be repaid:

Payable on or before one year from date, with interest from maturity at at 6%, payable semi-annually.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 112 on plat of Property of the Estate of Tully P. Babb, recorded in Plat Book QQ at Pages 162-163, in the R.M.C. Office for Greenville County, and having according to said plat the following metes and bounds, to wit:

"BEGINNING at an iron pin on the northern side of Cleveland Street Extension, at the joint front corner of Lots 111 and 112, and running thence with line of Lot 111, N. 19-39 E. 309,8 feet to iron pin in line of Lot 110; thence with line of Lot 110, S. 75-19 E. 155 feet to iron pin on Stonehaven Drive; thence with said Stonehaven Drive S. 17-41 W. 363 feet to iron pin on the curve of the intersection of Stonehaven Drive and Cleveland Street Extension; thence with the curve of the intersection of Stonehaven Drive and Cleveland Street Extension, the chord of which is S. 77-27 W. 40.4 feet to iron pin; thence with Cleveland Street Extension N. 42-48 W. 92.1 feet to iron pin; thence continuing with said Cleveland Street Extension N. 50-15 W. 54.3 feet to the beginning corner."

Being the same property conveyed to the mortgagor by the mortgagee by deed of even date, to be recorded herewith, and this mortgage is given to secure a portion of the purchase price.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
