All those certain pieces, parcels or lots of land with the improvements thereon, easterly side of State Highway No. 291, near the City of Greenville, South Carolina, being shown as Lots Nos. 4 adn 5 on a plat of the subdivision of Lot 9 of the J.H. Sitton property (Plat Book II,page 127), made by Woodward Engineering Company, dated June 15, 1957, and recorded in the RMC Office for Greenville County, S.C. in Plat Book NN, page 105, and having according to said plat the following meter and bounds, to wit:
