WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Six Thousand, Seven Hundred Fifty and 00/100

DOLLARS (\$ 6,750.00 ), with interest thereon from date at the rate of Six & one-half (6½%) per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Simpsonville, and shown as Lot No. 103 on plat of Hunters Acres Subdivision, recorded in the R.M.C. Office for Greenville County in Plat Book BB, at page 51, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Boyd Avenue at the joint front corner of Lots 102 and 103, and running thence with the joint line of said lots, S. 1-14 W. 207.4 feet to an iron pin; thence N. 89-56 W. 80 feet to an iron pin at the joint rear corner of Lots 103 and 104; thence with the joint line of said lots, N. 1-14 E. 208.9 feet to an iron pin on the Southern side of Boyd Avenue; thence with the side of said Avenue, S. 88-46 E. 80 feet to an iron pin at the point of beginning.
