Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville , State of South Carolina:

ALL that lot of land with the buildings and improvements thereon situate on the Northeast side of Cliffside Lane near the City of Greenville in Greenville County, South Carolina, being shown as Lot Nos. 305 and 306 on plat of Section C of Woodfields Subdivision, recorded in the RMC Office for Greenville County, South Carolina in Plat Book W, Page 133 said lot fronting 156.2 feet along the Northeast side of Cliffside Lane, and runs back to a depth of 150.2 feet on the Southeast side, to a depth of 154.2 feet on the Northwest side, and being 115 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
