"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

All that lot of land with the buildings and improvements thereon situate, lying and being on the southeasterly side of Crosby Circle, near the City of Greenville, in Greenville County, South Carolina shown as Lot No. 73 on plat of Paramount Park. made by Piedmont Engineering services, July 1949, recorded in the RMC Office for Greenville County, South Carolina, in plat Book W at page 57.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
