and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of

All that piece, parcel or lot of land with the buildings and improvements thereon,
situate, lying and being near the City of Greenville, in the County of Greenville,
State of South Carolina, being known and designated as Lot 11 on Plat of View Point
Place, which plat is recorded in the RMC Office for Greenville County in Book CC,
page 152, and having, according to a more recent plat of property of Thomas E. Frazier,
prepared by R. B. Bruce, Registered Land Surveyor, February 3, 1959, the following
metes and bounds to wit: Beginning at an iron pin on the Southwesterly side of Bayne
Drive joint front corner Lots 10 and 11 which iron pin is approximately 577.5 feet from
the curve of the intersection of Rainbow Drive (formerly View Point Road) and running
thence along the Southwesterly side of said Drive S. 43-10 E. 70 feet to an iron pin;
thence S. 32-20 W. 154.7 feet to an iron pin; thence N. 43-10 W 108 feet to an iron pin;
thence N. 46-50 E. 150 feet to an iron pin at the beginning corner.

ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.
