NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **on the Western side of Sable Court, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 24 as shown on a plat of Blue Mountain Park Subdivision prepared by Beeson Engineering Company, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book EE, page 121, and having according to said plat, the following metes and bounds:**

BEGINNING at an iron pin on the Western side of Sable Court at the joint front corner of Lots Nos. 24 and 25, and running thence with the line of Lot No. 25 N. 78-58 W. 203.1 feet to a point in the center of a branch; thence with the center of the branch as the line in a Northwesterly direction 110 feet, more or less, to the joint rear corner of Lots Nos. 24 and 61; thence N. 65-51 E. 227.16 feet, more or less, to the joint rear corner of Lots Nos. 23 and 24; thence with the line of Lot No. 23 S. 35-48 E. 164.4 feet to an iron pin on the Western side of Sable Court; thence with the Western side of Sable Court in a Southwesterly direction 124.8 feet, more or less, to the point of beginning.
