ALL that certain piece, parcel or lot of land, with the buildings and improve-
ments thereon, situate, lying and being in the City of Greenville, in the
County of Greenville, State of South Carolina, being known and designated
as Lot 225 on Plat of Pleasant Valley which plat is recorded in the RMC
Office for Greenville County, South Carolina in Plat Book P at pages 92
and 93, and having, according to said plat, the following metes and bounds,
