TO ALL WHOM THESE PRESENTS MAY CONCERN: **Bates & Cannon, Inc.**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----  
---Twelve Thousand Five Hundred and No/100-----DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 47 on Plat entitled Berea Heights, Section 3, recorded in Plat Book HHH at Page 147 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southeastern side of Albion Circle at joint front corner of Lots 47 and 48; thence with the line of Lot 48 S. 39-10 E. 167.5 feet to an iron pin at rear corner of Lot 54; thence with the line of Lot 54 S. 50-06 W. 100 feet to an iron pin at rear corner of Lot 46; thence with the line of Lot 46 N. 39-10 W. 170 feet to an iron pin on the southeastern side of Albion Circle; thence with the southeastern side of Albion Circle N. 51-50 E. 100 feet to the beginning corner.
