MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, J. H. Mauldin, of Greenville County,

.....(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the northern side of Charing Cross Road, being known and designated as Lot No. 13, of Section 3, of Brookwood Forest, as shown on plat recorded in the R. M. C. Office for Greenville County in Plat Book BBB, at Page 156, and being more particularly described as follows:
