"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the eastern side of Beatrice Street, near the City of Greenville, being shown as Lot No. 3 on plat of property of Eva Jones made by W. J. Riddle in October, 1945, and recorded in Plat Book Q at Page 37, and being more fully described as follows:

BEGINNING at a stake on the eastern side of Beatrice Street, 240 feet south from Frances Avenue at the corner of Lot No. 2, now or formerly owned by Robert A.
