BEGINNING on a stake at intersection of Harris Drive and Leona Avenue, the northwestern corner of Lot No. 20, and runs thence with the margin of Harris Drive S. 47-05 W. 200 feet to a stake, corner of Lot No. 22; thence with line of lot No. 22 S. 42-55 E. 160 feet to a stake; thence N. 47-05 E. 215.8 feet to a stake on the margin of Leona Avenue; thence with the margin of said street N. 48-30 W. 160 feet to the beginning.
