## To All Whom These Presents May Concern:

W. E. Shaw, Inc., a South Carolina corporation, with its principal place of

business in Greenville, S.C. (hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Nineteen Thousand and No/100-----(\$ 19,000.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments of One Hundred Thirty-Four and 29/100----(\$ 134.29)

Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in to the payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable. 25 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings under the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate. lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Pimlico Road, being shown as Lot No. 484 on a plat of Section D, Gower Estates, dated May, 1964 by R. K. Campbell and Webb Surveying & Mapping Co., recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Pages 192 and 193 and being more particularly described as follows:

BEGINNING at an iron pin on the southeastern side of Pimlico Road, joint front corner of Lots 483 and 484, and running thence with the joint line of said lots, S. 64-43 E. 158 feet to an iron pin, joint rear corner of said lots; thence along the rear of Lots Nos. 484, 497 and 496, S. 26-12 W. 121 feet to an iron pin, joint rear corner of Lots 484 and 485; thence with the joint line of said lots, N. 63-05 W. 160 feet to an iron pin on the southeastern side of Pimlico Road, joint front corner of said lots; thence with said road, N. 27-05 E. 116.4 feet to an iron pin, point of beginning; being the same conveyed to the mortgagor corporation by Conyers & Gower, Inc. by its deed dated May 2nd , 1966, to be recorded herewith.
