"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, GANTT TOWNSHIP, BEING KNOWN AND DESIGNATED AS LOT NO. SIX (O) OF THE ESTATE OF R D. HICKS, DECEASED, AS SHOWN ON A PLAT THEREOF MADE BY G.A. ELLIS, SURVEYOR, DATED MAY 28, 1945, RECORDED IN THE R.M.C.
