NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, located near Pleasant Grove Baptist Church on the Old Greenville-Spartanburg Road, being shown as Lot No. 20 on a plat of property made for the J.M. Mattox Estate by H.S. Brockman, Registered Surveyor, dated November 6, 1952, amended February 25, 1956, recorded in Plat Book JJ, page 127, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at a stake at the joint rear corner of Lots Nos. 20 and 19 on the south side of the Old Greenville-Spartanburg Road, and running thence along the south side of the said road, S. 48-40 W. 200 feet to a stake at the corner of a newly cut road; thence S. 41-20 E. 100 feet along the east side of said new street to a stake at the corner of Lot No. 21; thence N. 50-25 E. 196.7 feet to the joint corner of Lots Nos. 21, 18 and 19; thence N. 39-34 W. 105.1 feet along the rear line of Lot No. 19 to the beginning corner.
