SEND GREETING:

WHEREAS, I the said Lois P. McCall

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Six hundred twenty and no/100 - - - - - (\$620.00 ) Dollars, with interest from the date hereof at the rate of seven per cent ( 7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

Twenty five and no/100 - - - - - (\$ 25.00 ) Dollars

, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor— in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, having the following metes and bounds:-

BEGINNING on a stake in the Rutherfordton Road, thence S. 1-00 E. 105 feet to a stake on the Collins line; thence N. 84-45 E. 120 feet to a stake; thence N.9-20 W. 130 feet to a point in said road; thence with said road the line S. 70-30 W. 105 feet to the beginning corner, containing onethird acre more or less and is a part of the same land recorded in R. M. C. Office for Greenville County in Vol 145, page 373.

This is the same property conveyed to me by J. T. Parris by deed dated December 1, 1947, recorded in R. M. C. Office for Greenville County in Vol. 398, page 151.
