"ALL that certain piece, parcei or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Creenville on the Western side of Hunt's Bridge Road and being known and designated as a portion of Lot #1 on a plat of Blueberry Park, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book BB at page 18 and being more fully described as follows:
