NOW KNOW ALL MEN, that in consideration of said loan and to further secure the payment of said Note and also in consideration of three dollars (\$3) to the Mortgagors in hand well and truly paid by Mortgagee at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, the Mortgagors hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate situated in the County of Greenville and State of South Carolina, to-wit: All that certain lot of land lying in the State of South Carolina, County of Greenville on the western side of Creighton Street shown as Lot No. 3 on plat of Colonial Hills, Section 2 recorded in the R.M.C. Office for Greenville County in Plat Book RR at page 185 and being further described as follows: BEGINNING at an iron pin on the western side of Creighton Street at the joint front corner of Lot Nos. 3 and 4 and running thence along the line of Lot No. 4, N. 80-15 W. 150 feet to an iron pin; thence N. 9-45 E. 100 feet to an iron pin at the joint rear corner of Lot Nos. 2 and 3 and running thence along the line of Lot No. 2, S. 80-15 E. 150 feet to an iron pin on the western side of Creighton Street; thence along the western side of Creighton Street, S. 9-45 W. 100 feet to the point of beginning.

To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue.
