MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: A. J. Hendrix and Blanche A. Hendrix

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **Bank of Travelers Rest**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of -----

Fifty Five Hundred and No/100 ----- DOLLARS (\$ 5500.00),
with interest thereon from date at the rate of **6** per centum per annum, said principal and interest to be repaid:

Payable \$185.00 on December 1, 1966, and a like payment of \$185.00 on the 1st day of each third month thereafter, payments to be applied first to interest and then to principal, until paid in full.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the eastern side of Ware Street, in the City of Greenville, and described as follows:**

"BEGINNING at the corner of lot now or formerly owned by H. C Alexander, and running thence with line of said lot N. 71-30 E. 130 feet to an iron pin; thence S. 18-30 E. 50 feet to an iron pin; thence S. 71-30 W. 130 feet to an iron pin on Ware Street; thence with said Ware Street 50 feet to the beginning corner."
