"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, about four miles from the Greenville County Court House, on the eastern side of the County road as marked on plat, now known as Hollywood Drive, just off State Highway Po. 81, being known and designated as Tract No. 6-A on plat of "Mixie Farms" made by Dalton & Neves, Engineers, July 1938, recorded in the UMC Office for Greenville County in Plat Book L at page 3, and containing 4.25 acres, being more particularly described as follows:
