All that certain piece, parcel or lot of land situate, lying and being near the City of Greer, in the County of Greenville, State of South Carolina, at the Morthwestern corner of the intersection of Lee Street and Maryland Avenue, being known and designated as Lot No. 54 of a subdivision shown on a plat prepared by Dalton & Neves, Engineers, dsted April, 1947, recorded in the RMC Office for Greenville County, S.C., in Plat Book "P" at page 119, said plat being entitled "Development No. 2, Victor Monaghan Co., Division of J. P. Stevens & Co., Inc., Greer Plant." The property herein conveyed has, according to said plat, the following metes and bounds, courses and distances, to-wit:
