\$225.56 per month until paid in full, with each payment applied to payment of interest and balance to principal, with the right to anticipate additional payments provided they are in sums of \$225.56 each or multiples thereof,

with interest from date at the rate of 6.6 % per centum per annum until paid; interest to be computed and paid monthly ~~annually~~, and if unpaid when due to bear interest at same rate as principal until paid, and we have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

Quinn, his heirs and assigns forever,

ALL that piece, parcel or lot of land with improvements thereon situate, lying and being in the County of Greenville, State of South Carolina in the City of Greenville on the North side of Haynie Street and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Western intersection of Haynie Street and a 20-foot alley and running thence along the North side of Haynie Street, S. 81-40 West 156.7 feet to a pin; running thence N. 9-43 West 53 feet to a pin; running thence N. 82-21 East 32.9 feet to a pin; running thence N. 77-32 East 12 feet to a pin; thence N. 7-42 West 11.1 feet to a pin; thence N. 82-18 East 8 feet to a pin; thence N. 7-42 West 53 feet to an iron pin; running thence N. 82-0 East 111.2 feet to a pin on the West side of a 20-foot alley; thence along the West side of said alley, S. 4-45 East 116.6 feet to the beginning corner.
