"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, located in the Town of Simpsonville, on the East side of S. Pliney Circle, known and designated as Lots 27 and 28 of the subdivision known as LEAGUE ESTATES, according to a survey and plat made by W. J. Riddle, Surveyor, October, 1941, said plat being recorded in the RMC Office for Greenville County in Plat Book "K", at Pages 111 and 112, and having, according to said plat, the following metes and bounds, to-wit:

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
