Greenville, South Carolina, JOE BARTON JONES of  
hereinafter called the Mortgagor, send(s) greetings:

organized and existing under the laws of the State of North Carolina, hereinafter

sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville,

Heights, Section No. 2, by Dalton & Neves, Engineers, recorded in
