"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, situated on Virginia Avenue in the City of Greer, being known and designated as Lot No. 27 on a plat of Development No. 2, Victor Monaghan Company, Division of J.P. Stevens & Co., Inc., Greer Plant, prepared by Dalton & Neves, Engineers, dated April, 1947, and recorded in the R.M.C. Office for Greenville County in Plat Book "P", page 119, and having, according to said plat, the following courses and distances:
