"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Gower Street and being known and designated as Lot No. 4 on a plat of property of W. O. Groce as made by R. E. Dalton, Engineer, in March, 1966, which plat is of record in the R.M.C. Office for said county and state in plat Book Q, at page 188, said property being described by metes and bounds as follows:
