MORTGAGE OF REAL ESTATE .

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

To All Whom These Presents May Concern:

We, Clarence Cooper and Sybil M. Cooper, of Greenville County,

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Six Thousand and No/100-----(56,000,00) Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Garren Drive, being known and designated as Lot No. 206 of Section II of Oak Crest as shown on plat thereof prepared by C. C. Jones & Associates, Engineers, January, 1955 and recorded in the R. M. C. Office for Greenville County in Plat Book GG, at pages 130 and 131 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at a pin on the eastern side of Garren Drive at the common front corner of Lots Nos. 207 and 206, and running thence with the line of Lot No. 207, S. 88-11 E. 172.8 feet to a pin in the rear line of Lot No. 198; thence with the rear line of Lots Nos. 198 and 199, N. 11-55 E. 64.2 feet to a pin at the corner of Lot No. 205; thence with line of Lot No. 205, N. 86-04 W. 183.9 feet to a pin on the eastern side of Garren Drive; thence with the eastern side of Garren Drive, S. 1-49 W. 70 feet to the beginning corner; being the same conveyed to us by Paul N. Bayne by deed dated February 17, 1956 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 546 at Page 537."
