One (1) of the C. T. White property as shown on plat prepared by W. J. Riddle, Surveyor, dated Nov., 1948 and which plat has been recorded in the R. M. C. Office for said County in Plat Book WW, page 527. This being the same property which was conveyed to James D. Cordell by Bruce H. Moseley and John K. Temple, Jr. by deed recorded in said office in Deed Book 730, page 83.
