bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Atlanta Postal Credit Union, its successors and assigns:

ALL that lot of land with the buildings and improvements thereon, situate, on
the south side of High Valley Boulevard on the east side of Creek Shore Drive
near the City of Greenville, in Greenville County, South Carolina, being shown
as Lot 55 on plat of Fresh Meadow Farms made by M. H. Woodward, Engineer,
May 21, 1945, and recorded in the R. M. C. Office for Greenville County, South
Carolina, in Plat Book M at page 127 and having, according to said plat, the
following metes and bounds, to-wit:

BEGINNING at a point on the south side of High Valley Boulevard, joint front
corner of Lots 54 and 55 and runs thence north 81 degrees 23 minutes west 50
feet to an iron pin; thence with the curve of High Valley Boulevard and Creek
Shore Drive (the chord of which being south 58 degrees 04 minutes west 56 feet)
to an iron pin on the east side of Creek Shore Drive; thence south 14 degrees 16
minutes west 214.7 feet to joint corner of Lots 55 and 56; thence with line of Lot
56, south 81 degrees 23 minutes east 113.7 feet to an iron pin; thence with line of
Lot 54 north 8 degrees 37 minutes east 250 feet to the beginning corner.
